

**IMUA FAMILY SERVICES, PADDLE IMUA INSURANCE PROGRAM
PADDLER WAIVER AND RELEASE OF LIABILITY**

In consideration for being allowed to participate in Paddle Imua, sanctioned by Imua Family Services and its member organizations' athletics/sports programs, and related events and activities, the undersigned acknowledges and agrees to the following:

1. Agree that prior to participating, they each will inspect the facilities. They will inspect equipment to be used, and if they believe anything is unsafe, they will immediately advise their coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue Imua Family Services, its member associations, its affiliated partners, their respective administrators, directors, agents, coaches, and other volunteers or employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
5. Promotional Rights: The undersigned grants Imua Family Services, and its affiliated clubs and sponsors, permission to telecast, show and/or print and publish any and all pictures taken of me or the crew collectively in conjunction with Paddle Imua, the undersigned releases Imua Family Services and its representatives, affiliated partners and sponsors all rights to publication and/or other use of aforementioned pictures for their brochures, or other promotional and/or other printed material without remuneration. Also the undersigned grants Imua Family Services and Bluesmiths permission to include my email address on their listserv. I understand that after receiving emails I can unsubscribe from each listserv.

EACH OF THE UNDERSIGNED HAVING READ THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT THEY HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT VOLUNTARILY. IF THE RACE PARTICIPANT IS UNDER 18 YEARS OF AGE, THIS WAIVER MUST BE SIGNED BY A LEGAL PARENT OR GUARDIAN CONSENTING PARTICIPATION.
